The position of Road Safety Officer (RSO) is shared between the Shires of Bland, Coolamon, Junee and Temora. The RSO shares their time between the four offices and covers 15,825 square kilometres.



### **Accessibility Upgrades for Temora Library**

The Temora Library will be getting an \$189,014 upgrade thanks to funding from the NSW Government's Public Library Infrastructure Grant program.

Member for Cootamundra Steph Cooke announced the library will receive improvements including a new outdoor reading and activity space, new accessible toilet facilities and wheelchair accessible

Ms Cooke said the funding would improve access to the library for the entire community

"This funding is vital to ensure everyone, no matter their mobility level, can access the fantastic services the library has to offer," Ms Cooke said

"I am so pleased to be able to announce this grant for the Temora Library and to see this important community hub get these improvements.

Branch Librarian Wendy Manning said the grant was fantastic news

"It's very exciting and it's going to provide some much-needed upgrades to the library. being such a big community facility it's going to be utilised by everybody," Ms

"We're going to create more accessible toilets so people are going to be able to get in and out a lot easier. We're going to have an outdoor reading room which will open the library up more, create more of a community hub and it will be a more inviting place.

The Public Library Infrastructure Grant program is a \$6 million grant program directed to 20 public library projects across NSW. The vast majority of the funding this year has been directed to libraries in regional areas including those impacted by the bushfires.

The funding allocation for library infrastructure brings the total NSW Government support for libraries in 2019/20 to \$36.5 million, building on the NSW Government's 2019 election commitment to provide an extra \$60 million to libraries over four years.

The Library Council of NSW, assisted by the State Library, assessed the applications for grants for local libraries to improve their facilities, mobile library resources and major

Rate Notices for the 2020/2021 financial year will be issued this month.

#### How are my rates calculated?

There are four main rating categories residential, business. farmland and mining. Your rates are calculated by Council based on the value of your land (the NSW Valuer General's Office issued Land Valuation notices in March this year), the category your property falls under and any pension concession you may be eligible to receive.

The rating category or sub-category is shown on your Rate Notice. If the use of your land changes, or is different to what is shown on your Rate Notice, it is your responsibility to notify

There are a range of services for which Council is required to place a levy on that is separate to funds raised by general rates. These

- Domestic waste all residential properties within the designated area are charged a domestic waste charge. Non-vacant properties receive a weekly kerbside collection as part of this charge
- Trade waste nonresidential properties within the designated area are charged a trade waste charge.
- Storm water levy all rateable occupied properties in the 'urban area' receive an annual charge to raise revenue to fund the upgrade and general maintenance of the stormwater drainage system.
- Sewerage service all residential properties to which sewer is available are charged a

## What if I'm a pension concession card holder:

Council on 6980 II00.

All NSW Councils offer a rebate of half of the general rate up to \$250, and half of the sewerage charge up to \$87.50. The maximum rebate pensioners are eligible for is \$337.50 each year. If you are a Pension

Concession Card holder, or a Department of Veterans Affairs (DVA) Gold Card holder stamped TPI or EDA, you may be eligible for a rebate on your primary residence. If you start receiving the pension after the commencement of the rating period, you will be eligible for a part year pension rebate at the beginning of the next quarter. Application forms are available from Council's offices. You may also be eligible for a concession on your water bill. Please visit Goldenfields Water for more information, NSW does not grant concessions on Health Care Cards.

#### Can I receive my rates notices electronically? Ratepayers can now

receive their rates notice electronically. Ratepayers control the registration of their email address and are given access to the site via a username and secure password. This facility will also archive notices received after the date of registration so they can be accessed by the ratepayer at any time

## TEMORA FLOODPLAIN RISK **MANAGEMENT STUDY**

The Temora Flood Study was carried out in 2019 and has led to further funding to complete the Temora Floodplain Risk Management Study and Plan. This funding supports the delivery of Stages 2 and 3 of the Temora Floodplain Management Program and will build on the 2019 Flood Study.

The purpose of the next stages of the program is to assess the man agement issues identified in the Stage I study, investigate management options, provide recommendations and develop a risk management plan detailing how flood prone land within the study area will be managed in the future.

Council is currently in the process of selecting a flood consultant to assist Council with this project and will soon seek further input to the project

through a committee and community consultation.

The project will compliment the current floodplain risk management studies and plans currently underway at Ariah Park and Springdale vil-

Have you ever wondered about the origin of your street name or a local park? Many locations don the surname of families still living in the region, but other names are a little more cryptic.

This year we will delve deeper into the names we see on signposts across the Shire in our series "What's in a Name?" Each month we are looking at themes under which our streets and parks have been named.

- Government Surveyor who laid out the original Temora Town boundaries. It was renamed "Crowley St" on 2nd February. 1926. Sherwood Road –

- Truskett Street named after the District Inspector of Schools when Temora West School was planned
