CEMETERY - RESERVATIONS-

Reservations in the "NEW" and "LAWN" cemeteries are only permitted on special application to Council, and in such cases where permitted, the full interment fee and cost of reservation plaque is to be paid.

- PLAQUE PHOTOS

(a) Cemetery plaque photos are a matter for the deceased relatives to arrange.(b) Plaque photos are to be 5cm x 7cm oval type.

Arrangements for the purchase and installation of the vase shall be a matter between the client and Funeral Director. Council to subsidise rental up to sum of \$750 annually. - The conditions of the Industrial Agreement providing for payment of untaken sick leave is terminated from 1 October, 1992, and conditions of the agreement have been extended to all current employees as a contract of employment. TIMBER - REMOVAL FROM ROADSIDES	-	No standing timber is to be removed on permit take timber from roadsides.	
TREE REMOVAL ON ROAD RESERVES	-	That it is prohibited for anyone to fell or in anyway damage a standing tree on a road reserve. This policy includes all trees whether alive or senescent and includes removal of part of the tree such as branches or burls. This policy must be abided by unless specific approval of the Council is granted.	
TREE REMOVAL & PRUNING	-	The Urban Overseer be granted delegated power to remove street trees when the tree is 1. Diseased 2. Senescent 3. Poses a potential danger to residents or 4. Is an unsuitable planting in its location. In decisions to remove trees, the residents affected must be consulted. [CM 16/12/04] Refer Vegetation Agreement – Country Energy	
TREE PLANTING	-	No trees may be planted on roads or footpaths without approval of Council. Council will supply trees for planting.	
VANDALISM REWARDS		Set a maximum level of \$10,000 for information leading to the conviction of vandals; There be no blanket policy on the payment	
		of reward for conviction of vandals;
